APPLICATION INSTRUCTIONS

Application conditions

The temperature of the air should be at least +5 °C, and the relative humidity of the air below 80 %.

Mixing components

Depending on the condition of the sauna, add 0.1 to 0.2 liters of Saunapesu to 5 liters of water. pH value of ready-to-use solution: approx. 2.

Application

Depending on the condition of the sauna, add 0.1 to 0.2 liters of Saunapesu to 5 liters of water.

DISSOLVING LIME:

Use a 10–15% solution. Undiluted Supi Saunapesu can be used on persistent lime scale deposits and dirt stains.

BLEACHING SAUNA BENCHES:

Mix with an equal amount of water (1:1) and let work for approx. 15 minutes.
